TERRI KOHLRIESER, ASST COUNTY PROSECUTOR OFFICE – IF WE ARE LOOKING FOR HELPERS TO CLEAN UP ROADS, PROBATION INDIVIDUALS LOOKING FOR COMMUNITY SERVICE. BARB ALLEN IS IN CHARGE OF GETTING INDIVIDUALS FOR POSSIBLE CLEAN UP.
