NORM CAPPS MADE A MOTION TO ACCEPT THE MEETING MINUTES FROM JUNE 18, 2019, 2ND BY GREG KESSEN, ROLLCALL

NATALIE SCOTT, FISCAL OFFICER -

NORM CAPPS MADE MOTION TO PAY BILLS OF \$43,463.17, 2^{ND} KEVIN COX, ROLLCALL. GREG KESSEN MADE MOTION TO APPROVE MAY BANK RECONCILIATION, 2^{ND} NORM CAPPS, ROLLCALL.

GREG KESSEN MOTION TO REAFFIRM RESOLUTION#190702-01 TO APPROVE 2020 BUDGET AS PRESENTED. BUDGET WILL BE SUBMITTED TO ALLEN COUNTY AUDITORS OFFICE FOR APPROVAL, 2^{ND} NORM CAPPS, ROLLCALL.
