PERRY TOWNSHIP TRUSTEES MET IN REGULAR SESSION, CALLED TO ORDER AT 7:30 BY CHAIRPERSON KEVIN COX. GREG KESSEN PRESENT. ROLL CALL BY FISCAL OFFICER. NORM CAPPS ABSENT. THE PLEDGE OF ALLEGIANCE FOLLOWED.

GREG KESSEN MADE A MOTION TO ACCEPT THE CORRECTED MEETING MINUTES FROM JANUARY 18, 2022, 2ND BY KEVIN COX, ROLL CALL

GAVE STREAM ASSESSMENT SURVEY PRESENTATION. PROVIDED THEIR NEW ADDRESS ON 1870 SLABTOWN ROAD. RAIN BARREL REBATES AND ADOPT A HIGHWAY PROGRAMS OFFERED IN THE TOWNSHIP. TOWNSHIP HAD 2 GROUPS (PERRY BLUE RIBBON 4-H CLUB AND PERRY CHEERLEADERS) PARTICIPATE IN ADOPT A HIGHWAY. NOT ABLE TO GET 100% IN THE SCHOOLS YET BUT ABLE TO PRESENT THEM WITH THE SEEDLING PROGRAM.
