If this permit is granted, I/we agree to the following conditions:

- 1. That all Construction must comply with the **ALLEN COUNTY STANDARD CONSTRUCTION DRAWINGS**. The \$200.00 bond will not be returned to the applicant until the driveway meets all specifications set forth by Perry Township.
- 2. That the restoration of the road frontage shall be equal to or better than its original state.
- 3. That traffic will be maintained at all times, unless permission is granted by Perry Township to do otherwise.
- 4. That the necessary lights, signs, barricades, flagmen and watchmen are maintained for the protection of traffic at all times, during the work provided for under this permit. I/we and my/our contractor will fully comply with all instructions given by Perry Township as to the handling of traffic.
- 5. That if the roadway pavement or roadside drainage is damaged either by construction, construction equipment or by excessive weight, I/we and my/our contractor will complete the repairs as advised by the Perry Township.
- 6. That the driveway pipe, where required, must be installed concurrent with the construction of the driveway. The driveway pipe must be properly bedded as shown in the *ALLEN COUNTY STANADARD CONSTRUCTION DRAWINGS***DW-2 AND DW-3 drawings to prevent crushing by heavily loaded vehicles.
 - The size and type of driveway pipe specified by the Perry Township must also be installed before the bond can be released.
- 7. That the applicant will notify Perry Township 48 hours prior to the installation of any asphalt or concrete driveway.
 - If 48 hour notice is not made prior to the installation of any asphalt or concrete driveway, the applicant will forfeit \$100.00 of the \$200.00 bond.
- 8. That the permit will be valid for 180 days. The permit holder shall keep Perry Township advised as to the status of the driveway on a monthly basis.
 - Perry Township will notify the permit holder 150 days after the permit was granted.
 - This notification will be mailed to the mailing address listed above.
 - This notification will serve as a courtesy reminder that the permit holder now has 30 days to complete the driveway.
 - Not receiving said notification does not exempt the permit holder from any associated "extension fees" as listed below.
- 9. That if the 180 day period from the date the permit is granted to the date the driveway is completed is not met, extensions may be granted in 30 day increments.
 - There will be a fee of \$50.00 per 30 day extension.
 - This "extension fee" will be subtracted from the performance bond that is returned to the applicant upon completion and approval of the driveway.
- 10. That if the permit expires before the work has begun; a new application must be filed with Perry Township along with the associated fees.
 - The permit fee (\$100.00) (from original permit) will be retained by the Perry Township.
 - The performance bond (\$200.00) (from original permit) will be returned to the applicant.
- 11. That if the driveway permit application is made after the driveway is installed, a late fee of \$50.00 will be required.
 - \$100.00 Permit Fee
 - \$50.00 Late Fee
 - \$200.00 Performance Bond (returned to applicant after final approval of the driveway by the Perry Township).
- 12. That the applicant will notify Perry Township Inspector upon completion of the driveway.
 - If notice of completion is not made, the applicant will forfeit \$100.00 of the \$200.00 bond.
- 13. That if at any time in the future the driveway location is moved or the driveway is reconstructed with new materials, a new "Permit Application" must be submitted to Perry Township.
- 14. That only one (1) drive is allowed for each residential parcel of land.

- No U-shaped driveways will be permitted.
- Parcels with more than 500 feet of roadside frontage may be evaluated for more than one (1) drive.
- Driveways for agricultural purposes may be evaluated for an additional driveway on that parcel.
- All concrete driveways must stop a minimum of three (3) feet from the edge of pavement of the road.
- All concrete driveways must be one (1) inch lower than the edge of pavement of the road, where the concrete stops.
